专业简介

本专业为广东省重点建设专业，开设于 1993 年，1995 年开始招收本科生，2003 年获批二级学科硕士点。现已建成覆盖法学本科、法律硕士和法学硕士、博士、博士后科研流动站的完整人才培养体系。并建有教育部首批“卓越法律人才教育培养基地”、国家知识产权局“国家知识产权培训（广东）基地”两个国家级人才培养平台，建成“广东地方立法研究评估与咨询服务基地”、“广东地方法制研究中心”、“广东法治评价与研究中心”三个省级重点人文社科研究基地。已与 18 所境外科研院所和 21 家境内实务部门建立了合作关系或共建实习实践基地。拥有较强的教师队伍。

十三五期间，本专业以国家“双一流”建设为契机，以三个省级智库和两个国家级人才培养基地为抓手，旨在打造立足华南、面向全国的高水平理工科大学法学研究与人才培养的范本，建成全国重要的地方法制研究重镇、知识产权研究中心和高端法律人才培养高地。

Program Profile:

The program, as a key subject on the provincial level, set up in 1993 and began to enroll undergraduates in 1995. In 2003, the program had been authorized as secondary discipline master degree program and since 2004, depending on the “211” and “985” programmes, the law school has established a complete training system in bachelor of law, master of law, doctor of law and center for post-doctoral research. In addition, the program established two national training programs, including the first “Outstanding Legal Talents Training Base” of Ministry of Education, “IPR Talents Cultivation Base” of State Intellectual Property Office and three provincial key institutes for social science, such as “Guangdong Base of Local Legislative Assessment and Consulting Services”, “Center for Local Law Studies” and “Center for Law Evaluation and

Research”. Besides, the program has cooperated with 18 overseas research institutes and 21 domestic practice departments. There are 56 full-time teachers in the college of law today, including 18 professors, 21 associate professors, 8 doctoral tutors and 55 of them have a doctorate.

During the 13th Five Year Plan, the program focuses on creating a national template of high-level legal study and training department in university of technology, founding a prestigious center of local legal study and IPR research and establishing legal talents cultivation base, depending on the national strategy of “Double Top Construction”, three provincial Think Tanks and two national training centers.

And the program is prestigious internationally and domestically in areas of Local Law, Intellectual Property, Basic Law, Taxation law and case law studies.

五、第二课堂

专业简介

本专业为广东省重点建设专业，开设于 1993 年，1995 年开始招收本科生，2003 年获批二级学科硕士点。2008 年创建卓越法律人才实验班，2013 年纳入中共中央政法委员会、教育部联合实施的卓越法律人才培养国家战略计划。现已建成覆盖法学本科、法律硕士和法学硕士、博士、博士后科研流动站的完整人才培养体系。并建有教育部首批“卓越法律人才教育培养基地”、国家知识产权局“国家知识产权培训（广东）基地”两个国家级人才培养平台，“广东地方立法研究评估与咨询服务基地”、“广东地方法制研究中心”、“广东法治评价与研究中心”三个省级重点人文社科研究基地。已与 18 所境外科研院所和 21 家境内实务部门建立了合作关系或共建实习实践基地。拥有较强的教师队伍。

十三五期间，本专业以国家“双一流”建设为契机，以三个省级智库和两个国家级人才培养基地为抓手，旨在打造立足华南、面向全国的高水平理工大学法学研究与人才培养的范本，建成全国重要的地方法制研究重镇、知识产权研究中心和高端法律人才培养高地。

Program Profile:

The program, as a key subject on the provincial level, set up in 1993 and began to enroll undergraduates in 1995. In 2003, the program had been authorized as secondary discipline master degree program and since 2004, depending on the “211” and “985” programmes, the law school has established a complete training system in bachelor of law, master of law, doctor of law and center for post-doctoral research. In addition,

the program established two national training programs, including the first “Outstanding Legal Talents Training Base” of Ministry of Education, “IPR Talents Cultivation Base” of State Intellectual Property Office and three provincial key institutes for social science, such as “Guangdong Base of Local Legislative Assessment and Consulting Services”, “Center for Local Law Studies” and “Center for Law Evaluation and Research”. Besides, the program has cooperated with 18 overseas research institutes and 21 domestic practice departments. There are 56 full-time teachers in the college of law today, including 18 professors, 21 associate professors, 8 doctoral tutors and 55 of them have a doctorate.

During the 13th Five Year Plan, the program focuses on creating a national template of high-level legal study and training department in university of technology, founding a prestigious center of local legal study and IPR research and establishing legal talents cultivation base, depending on the national strategy of “Double Top Construction”, three provincial Think Tanks and two national training centers.

五、第二课堂

第二课堂由人文素质教育和创新能力培养两部分组成。

1.人文素质教育基本要求

学生在取得专业教学计划规定学分的同时，还应结合自己的兴趣适当参加课外人文素质教育活动，参加活动的学分累计不少于 2 个学分。

2.创新能力培养基本要求

学生在取得本专业教学计划规定学分的同时，还必须参加国家创新创业训练计划或广东省创新创业训练计划或 SRP（学生研究计划）或百步梯攀登计划或一定时间的各类课外创新能力培养活动（如学科竞赛、学术讲座等），参加活动的学分累计不少于 4 个学分。

5. “Second Classroom” Activities

“Second Classroom” Activities are comprised of two parts, Humanities Quality Education and Innovative Ability Cultivation.

1)Basic Requirements of Humanities Quality Education

Besides gaining course credits listed in one’s subject teaching curriculum, a student is required to participate in extracurricular activities of Humanities Quality Education based on one’s interest, acquiring no less than two credits.

2)Basic Requirements of Innovative Ability Cultivation

Besides gaining course credits listed in one’s subject teaching curriculum, a student is required to participate in any one of the following activities: National Undergraduate Training Programs for Innovation and Entrepreneurship, Guangdong Undergraduate Training Programs for Innovation and Entrepreneurship, Student Research Program (SRP), One-hundred-steps Innovative Program, or any other extracurricular activities of Innovative Ability Cultivation that last a certain period of time (e.g. subject contests, academic lectures), acquiring no less than four credits.
